

The mission of the Kenosha Police Department is to serve all people with respect, fairness, and compassion. We are committed to preserving peace, order, and safety: enforcing laws and ordinances; and safeguarding constitutional rights.

A thoughtful reflection of 2012 reminds us all at the Kenosha Police Department that it was a year marked with some very violent incidents; we had three individuals murdered in the City of Kenosha, compared to none in 2011. We also had a string of brutal attacks on citizens in the community and then on the officers assigned to work undercover to apprehend the suspects. Yet the men and women of the Kenosha Police Department did not give up in the pursuit to maintain the image that Kenosha is a great place to live, work and raise a family.



The Kenosha Police Department has assembled a professional and accomplished executive command staff to lead the men and women who make up the ranks of this fine department. With the retirement of both assistant chiefs in 2011, I changed the structure of the command staff to create a deputy police chief and a police inspector. Daniel Miskinis was selected to fill the newly created position of Deputy Chief of Police and Lewis Lindquist was named to the newly created position of Police Inspector. I am confident the new command structure will accomplish and improve the oversight needed.

The Kenosha Police Department remains committed to implementing best practices, evaluating our procedures, and improving processes by which we deliver service to our citizens. We will endeavor to maintain trust through open communication, operational transparency, and accountability of our actions. Collaborative efforts with our community groups and citizens to identify and solve problems are and will remain a priority of the Kenosha Police Department. An example of that partnership is the partnership we have with NAMI of Kenosha, which is featured in this report.

The Kenosha Police Department takes a multi-pronged approach to crime reduction. In 2012 we implemented the Community Service Officer (CSO) program, to allow officers to focus more on crime prevention. We do not concentrate solely on enforcement; we also focus on education and prevention programs to address issues that cause crime. The department has followed a community policing philosophy, and I believe that the partnerships established over the years have created positive change in our community. I am proud to report that the national trend of reduction of violent crime continued in the City of Kenosha during the past year.

Looking to the future, I reaffirm my commitment that together we will maintain only the highest, most professional standard in law enforcement. I believe the future of our great City is promising and bright. It is my honor to be your Chief of Police.

Significant Events



<u>Homicide</u> - May 21, 2012 - Officers responded to a residence in the 6300 block of 26th Ave in regards to a stabbing. On arrival officers forced entry into the residence and located the victim a 52 year old female deceased and the adult male suspect, who was taken into custody. On December 3, the suspect, Johnny L Young, plead guilty to 1st Degree Intentional Homicide.

Robberies - July 1, 2012 - The Kenosha Police Department received the first of sixteen reports of street level robberies committed by groups of juveniles which occurred over the summer. Many victims reported that they were just walking in the area when they were approached and attacked by these groups.

<u>House Fire</u> - July 5, 2012 - Officers responded with the Kenosha Fire Department for a report of a house fire. Officer Roberts was the first officer to arrive and found the south side of the residence was on fire. The daughter advised her parents were still inside the burning home. The mother has MS and cannot walk. Officer Roberts entered the burning attached garage and observed Paul Henrich trying to get PJ, his wife, out of the house. Officers Zurcher, Howard and Bandi arrived on scene. With the garage walls on fire and filled with smoke, the officers were able to get PJ out of the house and carry her to safety.

<u>Homicide</u> - July 9 2012 - Officers of the Kenosha Police Department responded with personnel from the Kenosha Fire Department to Nedweski Park, located at 1613-43rd Street, for a brush fire. While the fire was being extinguished, the body of a twenty year old female was discovered. The victim was identified as Lashe Zalar. With the assistance of the community and tireless efforts of the detectives and officers assigned, an arrest was made and the defendant is in custody awaiting trial.

<u>Medal of Valor</u> - July 24, 2012 - At the Police and Fire Commission meeting Chief Morrissey awarded Officers Roberts, Zurcher and Howard the Medal of Valor for their life saving efforts on July 5, 2012. Officer Bandi received the Life Saving Award. The Medal of Valor is the second highest award an officer can earn.

<u>Officers Attacked</u> – August 24, 2012 - In an attempt to identify and apprehend the suspects involved in these cases, undercover operations were conducted. Two undercover officers were walking in the 6100 block of 12th Ave when they were surrounded by approximately 25 male subjects. Individuals from this group attacked the officers. The suspects were quickly taken into custody by detectives. During the course of these investigations, detectives identified and arrested seven male suspects ranging in age from 14 to 16 years old. The suspects in these investigations were referred to court on charges ranging from Party to a Crime of Robbery, Party to a Crime of Battery, Disorderly Conduct, and Resisting Arrest.

<u>Justice Assistance Grant</u> - The Kenosha Police Department received \$21,630 in grant funds which were used to purchase mobile data computers for squads, an AED for the Safety Center and four tactical carbine rifles.

<u>Department of Transportation Grants</u> - The Kenosha Police Department was awarded \$106,935 in DOT grants for directed enforcement of speeding, seatbelt and drunk driving laws. With this grant came a \$10,000 allowance for the purchase of equipment which was used to purchase laser radar units and portable radios.



National Alliance on Mental Illness (NAMI) Kenosha County Inc. is a non-profit (501C3), all volunteer organization that was founded in 1983. NAMI Kenosha's mission is to improve the quality of life for persons affected with mental illness in our community. We accomplish this mission through advocacy, education, and support. Mental Health adovacy comes in many different forms. We respond to over 350 calls for assistance annually. We have established a very functional network in Kenosha that allows us to provide help for those persons trying to navigate the mental health system which can be a very difficult process. We continually promote recovery (there is no cure for mental illness at this time) while fighting the stigma that is associated with mental illness. We seek better access to mental health resources and treatment prgrams. Our nation is faced with many issues and we all must continue to strive for more **MENTAL HEALTH AWARENESS** in our community. All educational programs are evidence-based and presented by NAMI certified instructors at no cost to the public. Currently, we provide the following programs:

1. Family-To-Family Education Program (F2F) on mental illness specifically for families of a person diagnosed with a serious mental illness. This is our sixth consecutive year for the class. We have nearly 300 graduates since NAMI Kenosha started offering the class over 10 years ago. In 2012, we started to teach a F2F class in Spanish. The 12 week series of classes runs from 6:30 to 9:00 PM every Tuesday from mid-January to early April. The English version is held at the Kenosha County Disabilities Resource Center, 8600 Sheridan Rd, Kenosha. The Spanish version is conducted at the Boys & Girls Club, 1330-52nd Street in Kenosha.

The course covers information about schizophrenia, the mood disorders (bipolar disorder and major depression), panic disorder, obsessive-compulsive disorder, PTSD and borderline personality disorder. Other topics are coping skills such as handling crisis and relapse, basic information about medications, listening and communication techniques, problem solving skills, recovery and rehabilitation, and self-care from worry and stress. The course is designed specifically for parents, siblings, spouses, teen-age and adult children and significant others of persons with a severe and persistent mental illness. This course is not appropriate for individuals who live with a major mental illness(s).

- 2. In Our Own Voice Program (IOOV) provides persons living with a mental illness an opportunity to educate others by sharing their experiences with mental illness. We have seven certified IOOV presenters who have conducted 103 presentations to 2,234 persons since 2008. Each presentation takes about one hour.
- 3. Crisis Intervention Team (CIT) training is a 40 hour training which provides local law enforcement with a better tool kit when dealing with people with mental illness in crisis. Since August of 2007, 85 police officers/deputies have completed the course. Since 2010, we have partnered with the Kenosha Police Department, Gateway Technical College, and Kenosha County Mental Health to host the training locally. Fifty Kenosha Police Officers have completed the training. THANK YOU KPD for all your support, specifically Chief Morrissey and Sgt. John Rohde for bringing CIT to Kenosha.
- 4. Crisis Intervention Partner (CIP) training (a spin off from CIT) is 16 hour training for social workers, case managers, nurses, teachers, dispatchers, and jail staff to better handle persons with mental illness in crisis. Since 2010, 223 people have completed the course. Both CIT and CIP have been well received and will continue in 2013.
- 5. Two additional programs that we have initiated are **Walkabout Rewards** and a **pilot fitness program** with Community Support Program (CSP), Comprehensive Community Service (CCS), and the Kenosha YMCA. Both of these voluntary programs work to promote overall wellness. People affected with serious and persistent mental illnes have a 25 year shorter life span than those who do not. Better fitness can help. "What's good for the heart is good for the brain."

NAMI Kenosha also provides support groups for adults and adolescents affected with mental illness and their family & friends. Support groups meet twice a month at St Paul's Lutheran Church. Each session runs from 6:00 to 7:30 PM. There is no cost to attend.
