

















### **Significant Events**



**Officer Involved Shooting** – March 4, 2015 – At 1142 hours, officers responded to the 1500 block of 84<sup>th</sup> Street in reference to a 64-year old Kenosha man in a garage attempting to kill himself. Officers arrived and located the man in the garage armed with two knives. He ignored officers' commands to drop the knives and advanced toward the officers. To stop the threat to officers, Officer Torres fired one round at the subject striking him in the abdomen.

Officer Involved Shooting – March 14, 2015 – At 0932 hours, officers attempted to arrest Aaron Siler, a 26-year old Kenosha resident, on an active felony Probation and Parole warrant. Mr. Siler fled in a vehicle and led police on a short vehicle pursuit. He crashed the car and fled from the scene on foot. Officer Torres pursued Mr. Siler on foot and when confronted in a garage, Mr. Siler armed himself with a weapon. Officer Torres fired his handgun striking and killing Mr. Siler.

**Homicide** – September 12, 2015 – At 0315 hours, officers responded to the 5000 block of 33<sup>rd</sup> Avenue in reference to a death investigation. On arrival, officers found two young children deceased in a bed and their mother, Lucia Hernandez Alvarez, 34-years old, with self-inflicted injuries. Ms. Hernandez Alvarez is accused of drugging and killing her two children. She was treated at a local hospital and is currently in jail awaiting trial on two charges of 1<sup>st</sup> Degree Intentional Homicide.

**Attempted Armed Abduction** – October 22, 2015 – At 1643 hours, officers responded to the area of 50<sup>th</sup> Street and 16<sup>th</sup> Avenue in reference to an armed abduction attempt of a 52-year old Kenosha woman. The victim reported that a vehicle pulled next to her as she walked on the sidewalk. The lone occupant asked for directions and then pointed a pistol at her while telling her to get into the car. The victim ran from the vehicle, and the suspect drove away.

At 1925 hours on the same date, officers responded to the 400 block of 44<sup>th</sup> Street in reference to another abduction attempt, this time involving a 14-year old Kenosha girl. The girl reported walking past a vehicle and a suspect similar to the earlier abduction attempt. This time, the suspect was outside of his car and asked for directions. As the girl got closer to him, he produced a pistol and attempted to force the girl into his car. The girl pushed the gun away, kicked the suspect and ran away yelling for help. With the help of video from a local business, officers were able to identify the suspect in both of the incidents as Leroy E. Johnson, a 61-year old Kenosha resident. He is currently in jail awaiting trial.

**Homicide** – November 10, 2015 – At 1925 hours, officers responded to St. James Manor, located at 910-59<sup>th</sup> Street in reference to a stabbing. On arrival, officers located two victims, a 56-year old man and a 47-year old female, suffering from multiple stab wounds. Officers also located the suspect, Marcel Kudzin, 65-years old. It was reported that Mr. Kudzin stabbed the woman after an argument; the 56-year old man intervened and was stabbed 27 times. The woman was treated and recovered from her injuries, and the man died at the hospital. Mr. Kudzin is in jail and awaiting trial on charges of 1<sup>st</sup> Degree Intentional Homicide and Attempted 1<sup>st</sup> Degree Intentional Homicide.

#### **Spotlight on the Rotary Safety Center**

The Kenosha Rotary Safety Center, 5716 14th Avenue, is home to the Kenosha Police Department's Safety Education and Crime Prevention divisions. The Safety Center provides programs throughout the school year to public, private, and parochial school children in Kenosha. The Center encourages a positive relationship between students and the Police Department; promotes important safety values to elementary school classes; reduces the chance of children becoming victims of crimes; and promotes a safe environment around elementary schools. Additional support from the Kenosha Rotary Club has enabled the Safety Center staff to add a small theater to the facility for viewing safety films and studio facilities and equipment for producing new safety training videos and public service announcements. Over 560,000 local children have benefitted from programs at the facility to date.

In 2009, Mayor Keith Bosman and the City of Kenosha honored the Kenosha Rotary Club by renaming a portion of 14<sup>th</sup> Avenue in front of the Rotary Safety Center "Rotary Drive" for founding and continuing to support the Rotary Safety Center.
